



## Have Ohio Rejoin the Midwest Interstate Passenger Rail Commission (MIPRC) ADVOCACY TOOLKIT for AAO Members and Partners

*Updated June 22, 2024*

### AN IMPORTANT FIRST STEP

The [MIPRC](#) is the governing body that makes decisions about the Federal Railroad Administration (FRA) Midwest Regional Rail Plan. Ohio left the MIPRC over a decade ago, and it's time to rejoin.

The good news is, Ohio's legislature is taking action! **House Bill 488** - [Adopt the Midwest Interstate Passenger Rail Compact](#) – has bipartisan support and is finally getting hearings in the House Economic and Workforce Development Committee.

The legislature is preparing for summer break and **NOW** is a great time to push our advocacy efforts and prepare for the next steps in the legislative process!

### WHAT IS MIPRC AND WHAT DOES HB488 DO

MIPRC is a twelve-state coalition of leaders that manages interstate passenger rail operations in the region. Illinois, Indiana, Kansas, Michigan, Minnesota, Missouri, North Dakota and Wisconsin are current members. Iowa, Nebraska, **Ohio** and South Dakota are also eligible to join.

The main purposes of the compact are to promote, coordinate and support regional improvements to passenger rail service:

- Promote both current improvements and long-range plans for intercity passenger rail service in the Midwest.
- Coordinate interaction among Midwestern state officials, and between the public and private sector at all levels (federal, state and local).
- Support efforts of Midwestern state DOTs involved in developing and implementing passenger rail service.

**HB488** provides the framework for Ohio to rejoin MIPRC. It allows for four commissioners: the Governor or their designee, a member of the general public, and one member from each chamber of our legislature (one representative, one senator).

**HB488** does **NOT** provide funding to join MIPRC. The cost is estimated to be **\$25k/yr** and would be funded in the **Transportation Budget** beginning in 2025.



## WHY IS MIPRC IMPORTANT

As we reach out to our elected officials to advocate for Ohio rejoining MIPRC, we need to explain why it's so important to participate.

- **Why it's important NOW:** Ohio has three passenger rail routes that pass through, and the times they do are downright terrible. The Lake Shore Limited and the Capital Limited both pass through Toledo and Cleveland with smaller stops along the way, but these are all in the wee hours of the morning making travel for Ohioans tough. Along with similarly terrible times, the Cardinal in Cincinnati only runs three days a week. When we rejoin MIPRC, Ohio will have a seat at the table to advocate for improved service along these routes.
- **Why it's important IN THE FUTURE:** Ohio has four routes under study in the Corridor ID program and two more in the FRA Long Distance Study program. As these routes come to life, it's critical that Ohio have a voice to make sure riders can interchange between routes without long layovers.
- Finally, having an open discussion about MIPRC and passenger rail in general will give us an opportunity to show Ohio's legislature that this is important to ALL Ohioans!

## NEXT STEPS FOR HB488

**HB488** is assigned to the House Economic and Workforce Development Committee. It will have its first hearing on Tuesday, June 25 at 9:30am – [watch live on the Ohio Channel](#).

The first hearing is for **sponsor testimony**. **There will be no public testimony at this hearing.** Representatives **Ghanbari** (District 75 – R) and **Skindell** (District 13 – D) will present the bill and potentially answer questions from the committee. Because of the legislative calendar, this will be the only hearing before summer break. We MAY NOT have any more activity until after the November election, but that doesn't mean we can't reach out to our elected officials!
